Economic Development Update

- WKREDA Conf: December 8th & 9th, 2021 Russell County Economic
 Development hosted the WKREDA Conference. 50 participants from around the
 state attended the two-day conference at the Fossil Hotel filling up 23 hotel
 rooms. The conference was held during the day with a daycare presentation and
 a strategic planning workshop. Other activities included dinner at LaSada Lodge
 and an evening bowling session at Playdium Bowl. Russell County Economic
 Development hasn't hosted a WKREDA Conference since 2014.
- Strategic Doing- Energy Center: The goal of the energy center is to revitalize the oil patch museum and bring in all energy sources (adding wind and solar) and making it not only a museum, but a travel center and destination stop off of I-70 with a fueling station included on the 20 acres Russell Development Incorporated owns. Renderings of the project are available. Star Bonds (sales tax incentive through the State of KS) have also been discussed for this project to help repay for the project. No movement has been made currently, still in discussion phase.
- Possible Housing Incentive Program: Mike has developed a Housing Incentive Program. Planning on applying for grant funds from both Russell County Area Community Foundation and Dane G. Hanson in March of 2022. Program offers a range of incentives. Examples: paint program- grant for supplies and paint. Siding, windows & roof programs & outside remodels. Drafts of the plan are in place, modeled off a Norton, KS program. Grant donors (Dane G. Hanson is familiar with the program). Mike will present the drafts of the plan before grants are applied for.
- Promotion Grant/Marketing Training: Working with Fort Hays State University and others to bring Marketing Training to the area. Training will consist of 3 or 4 courses over a year. 75% of cost paid by Russell County Economic Development and 25% of cost paid by course attendees.
- Childcare Task Force- Program still in the works. No movement being made at this time.
- Strategic Planning: The plan is a working document on a continual basis. Main focuses and tasks have been identified. Tasks get added on as they come. (Additions & corrections can be made at any time). Review available at a different time.

Tourism Update

 Upcoming Conferences – Ashley will be going to Omaha, NE in February for International Boat & Travel Show, partnering with travel council to save money. This will determine if we need to have a booth set up in the future. This show is attended by families interested in traveling. In March Ashley will be going to Denver for the Denver International Sportsman's Expo. Again, partnering with the travel council to save money. She will also be attending the Heartland Byway Conference in Leavenworth, May 3rd-5th. This is a National Conference that only comes to Kansas every now and then.

Russell County Loan Program

Current Balance- \$50,321.12. Mike is working on one delinquent loan. Itchy Trigger Finger loan is now closed out.

E-Community Loan Program

All loans are current, no delinquent loans. There is no longer a financial limit per region set by Network KS. We have given out 7 loans, a total of \$239,500.00.

Economic Development Update

- SBA- Working with Northwest Kansas Planning & Development Commission. We currently have 4 clients that are pursuing or going to pursue approximately \$1.2 1.4 million in SBA loans locally. 2 clients are in Russell City and 2 are in Russell County for expansions or startups. 2 are expansions, 1 is the purchase of an existing business and 1 is for startup.
- Legislative Update- Attended WKREDA's legislative meeting. Discussed expanding the budge for moderate income housing & affordable childcare. Mike also attended the Farm Bureau legislative meeting.
- 13 Ways- Teamed up with Dane G. Hanson & Russell Specialty Books & Gifts with forming a "community book club" over '13 Ways to Kill Your Community'. 5-week program, 5 meetings to discuss the book. We will advertise this club and facilitate this book club. Meeting's will be at 12:00pm in Russell. After this class it has been discussed hosting one in Lucas later.
- Annual Report- Request city dues in March. Our dues are one tenth of the half cent sales tax evaluations. Mike has a presentation available for every city to view.
- County NRP Update- No movement being made at this time; project is on hold. We are waiting to see what the State is going to do. Currently stalled in senate.
- Housing- Mike is working on possible Waffle-Crete housing. Mike also plans to apply to Dane G. Hanson & RCACF for housing program funds.
- OC Internship Program- A partnership through Ogallala Commons. This year our goal to have 5 county wide internships. (We are not housing the interns, just finding them a sponsor and a host). Currently, Agrilead Inc. has agreed to sponsor 2 internships and host 1. Russell County Historical Society is going to host 2 interns and sponsor 1. We are talking with other entities like the City of Russell and Russell Regional Hospital.
- Strategic Plan Update- Working document that incorporates the NWKPDC comprehensive development plan. Mike is working with Kayla from the City of Russell on this. Housing is a huge goal on this— new sub-division, senior living facility, incentive program on a annual level, increase development and restoration of rental properties. Childcare is another big goal with this project. Childcare Aware of Kansas is going to come join us to facilitate our first meeting. Looking for qualified people to be on the committee.
- SBDC Programs or other wanted programs- Our goal is to have more of those this
 year. We had 2 last year. These programs are free for us to host and facilitate
 county wide through SBDC and FHSU. Classes Mike would like to haveResume/Cover letter writing training, Fundamentals SEO class, Business Plan
 Bootcamp & Life After Business.
- Sunflower Electric Project- Sunflower Electric wants to put in a 100+acre solar field east of Russell that ties into their grid. Supplemental energy during the peaks. Sunflower Electric hosted a meet and greet at the Fossil Hotel about it. There is an application with the county commissioners. Pending commissioners' decision.

- Other Clients/Projects/Program- 4 clients going through FHSU business plans currently. 3 businesses are startups, 1 business is expansion. BASE Grant letters of support for two clients. KIOGA is hosting mid-year convention here. We will be working with Andrea Krug Krause for visitor bags.
- Other Discussion- With new members we need to schedule a few meetings up in Lucas. New board members include, Malinda Walker, Jeannie Stramel & Morgan Jones. Meeting date is to stay on the 2nd Thursday of the week, if Mike cannot make it due to meetings, Ashley is supposed to present for him and vice versa. CVB Funding requests need to be discussed at the meetings instead of email.

Economic Development Update

- **Project Cover** Mike is working with the Kansas Department of Commerce & has responded to a RFI pertaining to a distribution center.
- <u>13 Ways-</u> Book club registration was closed at 16 participants. We are planning to eventually do one in Lucas or Luray. Program starts in Russell on next Monday. There has been a lot of interest in it. We currently have a waiting list for the next Russell Club.
- <u>wKREDA</u>- Mike attended wKREDA quarterly conference in Lincoln, KS. Learned about Historic Tax Credits, Rehabilitation Tax Credits, State and Federal. Plans to start out in Lucas and Luray first and apply for grant to get a survey done and do a district downtown for the National Register of Historical Databases. This would open eligibility for incentives, promotions, and others.
- **Project Doghouse** Oilfield Business. Local man from Russell wants to buy the business from Great Bend and move it here. Estimated investment \$350,000-\$400,000. Business plan has been started. Exploring the SBA 504 plan.
- OC Internship Program- Currently have sponsors/hosts for 4 out of the 5 students. RCHS wants video and audio and a 2-year program, so they are still narrowing down students for that position. Mike & Jeff Ochampaugh plan on taking the interns to the retreat in Texas in June to get the students trained and started. Participating businesses: Agrilead, Inc. & Russell County Historical Society.
- **Dorrance Park-** Been working with them to get a new restroom and park equipment for the park. Helping them apply for 3 different grant sources.
- <u>Confidential Project</u>- Plans to close April 1st, 2022. Possible E-community loan for financing a business remodel.
- Sunflower Electric Project- Sunflower Electric meet with commissioner on Monday 3/7/22. Presented a PILOT. \$516,260 for a 10-year total based off of the current mil levy. That is \$35,212 per year (\$352,120 over 10) from PILOT and then \$16,414 per year (\$164,140 over 10) of additional property tax on the land based of the current mil levy.

Tourism Update

- Ashely went to Omaha Nebraska for their National Sport Show. She went as part as Northwest Travel Counsel. Show was extremely family oriented, and she wants to go back next year just as Russell County. Attractions in Lucas and Wilson Lake spiked a lot of interest.

- <u>13 Ways Task Force Book Club</u> Wrapping up in Lucas. Succession Planning Workshop is a focus.
- <u>Training and Workshops</u>- One training/workshop every month until the year is over. Workshops currently scheduled are Marketing & Customer Engagement Workshop in June, Content Marketing 101 in July, and Cybersecurity in August. Had a request from Russell Regional Hospital to bring in a FHSU Customer Service Training. Plan on applying for grant funds for that training.
- <u>Project 22-</u> Possible land purchase/ building expansion in the City of Russell, started a business plan.
- <u>Project Promise-</u> \$400,000 expansions, services, and employees. Moving forward. Filed paperwork with Kansas Dept. of Commerce. Possible NRP applicant if it goes through.
- <u>Project RCA-</u> \$300,000 investment through SBA. Application was approved through the board. Waiting to hear back.
- **Project T-Bone-** Butcher shop in the northern part of the county. Working on regulations.
- **Food Project-** Alice Hill is still moving forward on the project. They meet Friday to go over everything again.
- <u>Childcare</u>- There was a strategic planning meeting with USD 407 and Russell Regional Hospital. Formed groups with childcare focuses. Looking at a Co-op Center. We have 2 clients that are interested in starting up childcare. A group in Lucas is looking to do something with childcare also. Setting up meeting with Scott Sproul with the Economic Innovation Center. Looking at grants through Hanson.
- Workforce Development Hanson/EICI has a grant program for our workforce program. Potential grant money of \$60,000.00 for different things. More details coming. Just released.
- NRP Tax Abatement- Public hearing has been scheduled. Meeting with all townships tonight to vote on the plan. Next up, School Boards.
- <u>Bootheel Tractor Parts Inc.</u> Opened up a distribution center in Russell. Distribution for agricultural parts.
- **Project 123** SBA application and business plan around \$750,000.00. New service to town, 5 to 10 jobs starting out.
- <u>Housing</u>- Developing program including incentives for fixing and cleaning up. Hoping to add support funds for the upper level RHID for sprinkler systems to be included. Vacant lot data base with City of Russell has helped to narrow down the lots available for building projects. Housing Assessment Tool- it's preferred that it's updated every 2 years not 5 years. We can use statewide assessments to add to the

Russell County Loan Program

Mike reported a balance of \$52,857.82, not including July's deposits. Brant's Market paid off their loan. One application in the process of being submitted, a business startup in Lucas (The Lounge), soon to be café on Main Street.

E-Community Loan Program

Mike reported on new programs. Loan review committee will need some training. One new program is called Grow Kansas, it's a loan and grant matching program. Currently no delinquent loans and no pending applications. Sarah LaRosh discussed the new programs & local & statewide funds.

Economic Development Update – Mike Parsons

- <u>City Dues</u> 1st presentation to the City of Russell has been given. After the City of Russell presentation, all other cities in the county got their requests with explanation of dues via mail. If the other cities would like to request an in-person presentation, Mike would be happy to do so. Full amounts were asked across the board and updates will be given as the process moves forward.
- NRP- All 12 townships approved the NRP. The NRP is a 50% at 5-year term, capped at \$500,000.00. Application process will be open for 3 years and should be in place at the end of the year. Next step after townships is the 4 school districts. (407,399,299,112) 3 of those 4 districts have been met with and have public hearing notices scheduled and will vote on it at the end of this month and the beginning of next month. Next Monday 399 votes, August 8th, 407 & 299 vote. We are still communicating with 112. Goal is to have public hearings completed by August and to have paperwork to the state and approved by the end of the year.
- <u>Intern/Apprenticeship Program</u>- Joined by Alice Hill. Hannah Gideon, intern for Agrilead Inc. spent a few days with Alice Hill at Step Back in Time Food Market in Luray. Harvest Ceremonies are being scheduled for intern's final reports. There is an Intern/Apprenticeship Program (through Ogallala Commons) incentive for the City of Russell as part of their \$25,000.00 in dues. Waiting to see how everything works out with dues.
- <u>Maker Space-</u> Makerspace has been writing grants and have received a few including the Community Service Tax Credits. (\$72,278.00)
- **Project Promise-** Expansion of over \$400,000.00, Russell business expanding into the County. Confidential client. Has applied for incentives through the Kansas Department of Commerce. Those applications are in the process of being reviewed by the state. Has the potential of expanding the tax base and creating employment.
- **Project 123-** New business, over \$750,000.00 investment just outside the Russell City limits. Potential of hiring about 10 employees and are looking for a building. They are set up with Small Business Development Center to start a business plan.
- <u>Project T-bone-</u> Meat Processing Business/Butcher Shop has been discussed. Searching for location and right partner.
- <u>Project Shellshock</u>- Group of individuals that would like to start a trap-league. They are looking at land. Possibly pursue some loans.
- <u>Play Park</u> Committee plans to re-do castle park--- all accessible playground. Cost around 1.5 million.
- <u>The Rendezvous-</u> Shared workspace. Found a possible building to be used for shared office/remote space. May take time to move forward due to waiting on the building to become available.

- Housing- Emma Estates/Fixing Up, Russell Co. Randy Speaker from the Kansas Department of Commerce (Housing Specialist) and Scott Sproul, Northwest Kansas Economic and Innovation Center, were in Lucas and in Russell for meetings. Good turn out at both locations. Fixing up Russell County is a housing renovation incentive program being developed. Matching Grant fund system. Emma Estates- New realtor. Discussion was had about Emma Estates. 56 acres ready for development. Split up into 10 different parcels. All infrastructure is there. \$10,000.00 per acre.
- <u>Childcare</u>- A partnership/committee to help combat childcare has formed. There is currently a community childcare survey for Russell County. Working on long term plans-short term goals. Mike has 4 clients pursuing daycare startups. Exploring tri or fourplex for daycare.

Russell County Loan Program

Mike reported there are no withdrawals since the last board meeting. One prospect going through a business plan with the potential of a \$45,000.00 request. This might change since we now have the Grow Kansas Loan program through Network Kansas. All loans are current with the E-Community Loan Program.

Economic Development Update – Mike Parsons

- Housing-Projects, MIH Applications —Potential of a couple more duplexes in Russell. Needing a developer for the project. We are looking to apply for MIH Funds for the Luray & Lucas area for the purchase and renovations of existing structures. Fixing up Russell County is an incentive plan for fixing up structures, tearing them down, newly added under the program: sprinkler systems for upper-level construction. Discussion about matching funds needs to be had then presented to the county. Program comes out of the ½ cent sales tax fund. Once the program has been narrowed down, Mike will present it to the board.
 - O <u>Discussion</u>- The ½ cent sales tax fund was discussed. Mike requests money from the 280 fund to go into fund 155. Mike will request information from the clerk about how the 280 & 288 funds work.
- Child Care-Committee Update, Project Scope Community Committee with the City of Russell, Hospital, Pure-field, etc., out of this committee a childcare survey was done. Almost 200 responses from the survey giving the committee good data to go off. A meeting was held with current & future childcare providers in the county at Fossil Creek Hotel & Suites. Good turnout along with Child Care Aware, Hansen Foundation & EICI. Programs and services were discussed for both current and start up providers. What they need the most is a "substitute" list. The school and hospital are planning on building a daycare center. Open only to employee's children. The committee is looking at either a duplex (two group homes) with shared back yard or a modular. Approval of Financials

Ashley went over the CVB financials. Accounts 150 (Operating Budget) and 410 (Tourism and Convention -Transient Guest Tax) are the CVB accounts. Transient Guest Tax funds from the state gets deposited into account 410 then gets transferred to account 150. CVB has five CDs; three have \$5,000.00 each, one has \$20,000.00 and the other one has \$30,000.00. The CD interest goes to account 150. Current cash in account 150 is \$165,082.67. If needed, the budget could be amended. Current cash in account 410 (not budgeted) is \$5,600.87. Mike discussed the Eco Devo financials. Eco Devo has five accounts. 155 (Operating Budget), 280 (Salaries), 158 (RCED Loan), 210 (Capital Improvements Fund), 497- (State Micro Loan Program -NO ACCESS; funds go back to the state). Half cent sales tax and capital improvement funds get deposited into account 280. The commission budgets \$360,000.00 for account 280 for salaries, anything over \$360,000.00 gets transferred into account 210. Account 155- Operating budget is \$180,000.00. The operating budget amount gets requested and gets moved from account 280 into account 155. What doesn't get used in account 155 at the end of the year goes back into account 280. City dues get deposited into account 155 and Storefront/Signage Grant funds come out of account 155. Eco Devo has three CDs. John Fletcher moved to approve financials from August 2022. Daron seconded the motion. Motion approved.

Tourism Update- Ashley Wickham

- Fiscal year 2022 Transient Guest Tax brought in the highest amount it has been in nine years at \$98,223.75. Fiscal year 2023 is currently at \$23,974.66 (without September numbers).

Approval of Minutes

John Fletcher moved to approve minutes from October 2022. Jeannie Stramel seconded the motion. John Quinday opposed. Motion approved, 9 to 1.

Approval of Financials

Mike reviewed the Economic Development funds with a year-to-date diagram to help explain the separation of accounts. The diagram was presented to all board members in their packets. Salaries and operating expenses need to be kept separate. Jon Birky moved to approve financials from October 2022. Daron Woelk seconded the motion. Motion approved.

Russell County Loan Program

Russell County Loan Program comes out of fund 158. The account has a remaining balance of \$50,061.04. Payments from Lux Detail stopped. Due to failure to pay, the account is going to Dan Krug. The Lounge in Lucas might request some leniency for a few months, account is currently not delinquent. No loan applications in currently.

E-Community Loan Program

No delinquencies currently. There are some business plans being developed that might pursue the E-Community Loan funds and/or the Grow Kansas funds. Interest rates on the E-Community Loans are 4%-5 year and 5%-10 year.

Economic Development Update – Mike Parsons

- <u>Economic Updates:</u> Legislative Session- WKREDA is updating their platform. The legislative committee has discussed calling a meeting for legislative updates.
- Fixing Up, Russell County Incentive Program: The plan was to apply for \$30,000.00 from RCACF; \$30,000.00 from Hanson and match with \$15,000.00 from the county half cent sales tax for a total budget of \$75,000.00. Eco Devo did not receive the grant from RCACF. They were not in favor of the program. We will reevaluate the program.
- <u>Child Care Updates</u>- There is confusion between the two childcare groups. One group is Russell Regional Hospital & USD 407. Their childcare program is employee based. The other group is more community focused, with the goal of opening more childcare facilities for all county residents. They are two different projects, going two different directions but going after the same funds. Discussion was had about letting one group go first so the two groups won't be battling for the same funds at the same time. An incentive program for the childcare providers has been discussed. Eco Devo and the City of Russell has asked the Chamber to partner and lead that program.
- YEC/CYA: YEC (youth entrepreneurship challenge- Network Kansas) CYA (commonwealth youth academy- Ogalla Commons). Mike is working with both of those programs through RHS. He has a meeting with Brad Banker today to discuss the programs, anticipating a February date for YEC and CYA date later in the year. This would be the second year for the YEC program at the high school. The Jag program was briefly discussed also.
- <u>Strategic Plan Review/Changes-</u> Pending update. Goal is to have it ready for the board next meeting.
- **Project Pivot-** Confidential client pursuing assistance.
- **Project Blank Canvas-** New client. We are reviewing the development opportunity profile and assessing the needs of the county to see what fits the client. Child Care was not an option.
- **Project Lantern-** Confidential client pursuing assistance.
- <u>Business Awards</u> 8 Business nominated- one business (Good Karma Micro-Dairy) received a regional award; the rest received merit awards. Ceremony will be December 5th in the Commissioners Chambers.

Other Projects

• Workforce Recruitment Plan- Grant opportunity available. We need to get together with the major employers in the county and demonstrate the need in our workforce. Russell County can apply for \$60,000.00 through the Northwest Kansas EICI (Economic Innovation Center Incorporated) to use as a recruitment tool.

- Tax Abatement Received the interlocal back from the state yesterday. Two words needed to be changed. Dan Krug changed the wording and sent it back to the state.
- Billboard Grant Program- Discussed with commissioners on Monday. Billboard by Toulon is more suited for Gorham/Russell businesses. Need to find another billboard to the East for the other side of the county. The commissioners will be the review board for the grant.
- Business Survey- The office is developing a Business Survey. The goal of this survey is to showcase the needs of the business community. Should be ready by the first of the year.
- LATCF (Local Assistance Tribal Consistency Fund) Has funds available for cost sharing counties. \$50,000.00 this fiscal year, \$50,000.00 next fiscal year. Russell County is eligible. Working with the Treasurer's Office to apply. Must apply by January 31st, 2023.
- Economic Development policy update is in review.
- Women in Business Workshop- Planning on having a ladies night.

Tourism Update- Ashley Wickham

- Ashley hosted the Northwest Kansas Travel Council Meeting in October at Granny Mae's. About 20 people attended.
- Hunting season is in full swing—Hunting banner is up, and radio ads are playing. Karla hosted a youth hunt last weekend at her place. There are a lot of community meals being held this weekend over the county for the hunters and community members.
- Task Grants- Grassroots Art Center received one of the grants.
- New Guide- should have it sometime in the first couple months of the new year.
- New Kansas Travel Guides will be in this week or next week.
- Trade shows start in January- Denver & Omaha
- Ashley attended a tourism conference in the last month. Had about 250 people attended. Ashley received an award.
- Providing bags for Plaid on the Plains/a partnership with Encore.

- Luray- Stag/Stagette on Saturday, Wyatt is still working on raising funds for the log cabin. In Dec. the Madrigal Fest is planned for the 4th.
- Russell County purchased a compactor for the landfill.
